The House Standing Committee on Oversight was called to order by the Chair Hall.

The Chair laid HB 4831 before the committee:

HB 4831

(Rep. Lightner) A bill to amend 1984 PA 431, entitled "The management and budget act," by amending section 261 (MCL 18.1261), as amended by 2017 PA 21.

Substitute (H-1) was adopted at the previous meeting on November 7, 2019.

Representative Lightner testified in support of HB 4831.
