COMMITTEE MEETING MINUTES

The House Committee on Commerce and Tourism was called to order by the Chair Wendzel.

The Chair requested attendance be called:

Representative Liberati joined the committee remotely.

Representative Roth moved to adopt the meeting minutes from October 19, 2021. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4994, HB 4077 and HB 4730 before the committee:

HB 4994 (Rep. Witwer)

A bill to allow for the charitable donation of unclaimed shoes held by persons engaged in the business of shoe repair.

HB 4077 (Rep. LaFave)

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 21106 (MCL 324.21106).

HB 4730 (Rep. Calley)

A bill to amend 1895 PA 161, entitled "An act to require county treasurers to furnish transcripts and abstracts of records, and fixing the fees to be paid therefor," by amending section 1 (MCL 48.101), as amended by 2015 PA 39.

Representative Cherry offered the following amendment to HB 4994:

1. Amend page 1, line 3, by striking out "state licensed".

2. Amend page 1, line 3, after "organization" by inserting "that is registered with this state".

Representative Cherry moved to adopt the amendment to HB 4994. The motion prevailed 9-0-0:
