COMMITTEE MEETING MINUTES

Skaggs)	A bill to amend 1978 PA 90, entitled "Youth employment standards act," by amending sections 2, 3, 20, 21, and 22 (MCL 409.102, 409.103, 409.120, 409.121, and 409.122), section 2 as amended by 1996 PA 438, section 3 as amended by 1997 PA 132, and section 22 as amended by 1980 PA 436.
