The House Committee on Regulatory Reform was called to order by Chair Tyrone Carter.

SB 702 (Sen. Singh)

A bill to amend 1980 PA 299, entitled "Occupational code," by amending sections 1206, 1209, and 1210 (MCL 339.1206, 339.1209, and 339.1210), as amended by 1997 PA 97.

Senator Singh; Don Romain, representing Douglas J Aveda; and David Dagenais, representing the Michigan College of Beauty, testified in support of SB 702.
