Dear Melissa Sweet,

I strongly support the Second Look 5-bill package (HB 4556-60 and SB 0321-25). The package gives judges the ability to review someone's sentence after 10 years in prison. I think that's an excellent idea for many reasons!

Long prison sentences:

- are unhealthy, costly, and fail to account for positive changes that many people make (against all odds) in prison.
- often keep people incarcerated for years on end - burdening their families, separating them from loved ones, and keeping them from medical care and basic liberty - even when there exists no public safety interest in their continued incarceration.
- result in many people growing old and infirm in prison.

Allowing hope and a chance to change is a **prisoner human rights issue**. And we know, as the research supports, that people age out of crime.

Pursuant to the Second Look 5-bill package, the judge's review after someone has been in prison 10 years, would not automatically get the person released. However, the judge can see and hear their progress and make a decision based on that.

I look forward to the benefits from the Second Look 5-bill package (HB 4556-60 and SB 0321-25). Thank you for your attention to this important issue.
