**Hello, my name is Jennifer Hart and I have three children, a 7 yr old, 5 yr old, and a 3 yr old. My oldest was in first grade last year during the shooting at Oxford high school. He knows, like all of his classmates and the majority of students across the district, what happened at the high school on November 30th. Earlier this month, they held a lockdown drill at his school. This time he asked me, "What if what happened at the big kids school happens again? What if it happens at my school?" I was a little caught off guard, but I tried to tell him that the teachers and his principal and everyone at his school works very hard to make sure it doesn't and that if it does, to keep them safe. And that its ok to feel scared, and thats why we practice so even if we're scared we know what to do. See, for my son who is in the second grade, these lockdown drills are for an event that they know all too well is real and CAN happen where they live. Our children in Oxford are living and learning in a world where gun violence is not just something on the news, its something that happened to them, to their classmates, to their neighbors and to their community. We are failing these kids and we need more regulations on gun ownership, because far too many of our kids are victims of irresponsible gun owners. And I'm not just talking bout those that have died or been physically hurt, but those that walk into their second grade classroom wondering if today is the day it happens at their school.**
