## COMMITTEE MEETING MINUTES

The House Committee on Tax Policy was called to order by Chair Neeley.

The Chair laid HB 4068 before the committee:

HB 4068 (Rep. Hood)

A bill to amend 1967 PA 281, entitled "Income tax act of 1967," (MCL 206.1 to 206.847) by adding section 253.

Representative Hood testified in support of HB 4068. Questions and discussion followed.

Representative Grant offered the following amendments to HB 4068:

1. Amend page 1, line 2, after "**2023**" by inserting "**and subject to the applicable limitations in this section**".

2. Amend page 2, line 1, after "**section.**" by inserting "**An individual taxpayer shall not claim a credit under this section for more than 6 verified blood donations in a single tax year.**".

Representative Grant moved to adopt the amendments to HB 4068. The motion prevailed 11-0-0:
