Besides the benefits to the students, the Legislative Fellowship Program is an investment for the House that will provide a pool of well-qualified and experienced candidates from which to hire new staff as the need arises.

PROGRAM GUIDELINES

- Republican and Democrat applicants will be chosen to participate based on the term for which they apply. These Fellows will each be assigned a House Mentor and a Host Office.
- Host Office staff and Mentors will train the chosen Fellows in the general responsibilities expected of legislative staff as well as assisting Fellows in designing and completing a term project as part of the educational experience.
- Hours and schedule are negotiable for each Fellow, with a preference for availability on two of the three Session days, but a minimum of 15 hours or a maximum of 20 hours of service per week must be maintained.
- Once gathered by Human Resources, Fellowship applications are reviewed by a bipartisan Selection Committee comprised of House Republican, Democrat, and Non-Partisan staff.

COMPENSATION

- Fellows will be paid \$15.00 per hour for their service. Paychecks will be distributed via direct deposit into a checking or savings account bi-weekly.
- Legislative Fellows may earn college credit for their legislative experience. Requirements to receive credit are determined by the school or program in which the student is enrolled. Each student is responsible for obtaining and providing to staff the necessary information regarding their program's requirements.
- Legislative Fellows may request a parking space in the Ferris parking lot at an expense of \$17.00 per pay period to be paid via automatic payroll deduction.

DESIRED QUALIFICATIONS

- Fellowship applicants must be current students enrolled in either law school or have sufficient credits to achieve a junior or senior collegiate academic status with a preferred 3.0 cumulative GPA.
- Applicants must possess a positive and professional attitude, a desire to learn, and good work ethic.
- Applications will be considered based on party preference, college major or career goals, prior work and/or volunteer experience, professional skills, and their hours of availability. Students with prior Legislative Internship experience are encouraged to apply.

HOW TO APPLY

- Interested students should submit a completed application form, a detailed resume, cover letter, a one or two-page personal statement, current unofficial academic transcript, and at least one letter of recommendation via email to HumanResources@house.mi.gov with "Legislative Fellowship Application" in the subject line.
