MINUTES OF THE COMMITTEE ON EDUCATION

October 1, 2015

Chair Price called the meeting to order.

Rep. Garcia moved to approve the minutes from the meeting held September 24, 2015. The motion prevailed.

Chair Price laid before the committee SB 103 – Pavlov – Education; teachers; performance evaluation requirements for teachers and school administrators; revise.

The following person filled out a testimony card stating a neutral position on SB 103 and wanted to testify but the Chair was not taking testimony at the meeting today.

Rep. Garcia moved to adopt the substitute H-7 to SB 103. The motion prevailed, the vote being 16-0-1.

1. Amend page 3, line 26, after "**2015-2016**" by striking out "**SCHOOL YEAR**" and inserting a coma and "**2016-2017, AND 2017-2018 SCHOOL YEARS,**".
2. Amend page 21, line 17, after "**2015-2016**" by striking out "**SCHOOL YEAR,**" and inserting a coma and "**2016-2017, AND 2017-2018 SCHOOL YEARS,**".

Rep. Garcia moved to adopt the amendments. The motion prevailed, the vote being 17-0-0.

1. Amend page 3, line 26, after "(i) by striking out "**FOR**" and inserting "**BEGINNING WITH**".
2. Amend page 4, line 5, by striking out all of line 5 through 7.
3. Amend page 21, line 17, after "(B)" by striking out "FOR" and inserting "**BEGINNING WITH**".
4. Amend page 21, line 19, by striking out all of lines 19 and 20.

The motion did not prevail, the vote being 6-8-3.
