HOUSE STANDING COMMITTEE ON REGULATORY REFORM

Wednesday, April 27, 2016 12:00 Noon Room 519 House Office Building

Representative Ray A. Franz, Chair, called the meeting to order.

Chair Franz requested attendance be called to establish a quorum of the appointed committee members:

Present: Reps. Franz, Brett Roberts, Yonker, Kesto, Lauwers, Crawford, Garcia, Iden, Howell, Dianda, Darany, Lane, Schor, Chirkun, and Moss.

Representative Brett Roberts moved to approve the minutes of the April 20th, 2016 meeting.

There being no objection, the motion prevailed by unanimous consent.

The chair laid HB 5568 before the committee:

HB 5568 (McCready) Liquor; licenses; issuance of a national sporting event license; expand to include United States Golf Association Amateur Championship.

Brett Visner, representing Michigan Beer and Wine Wholesalers Association, submitted a card in support of the bill but did not wish to speak.

Representative Brett Roberts made a motion to report HB 5568 with recommendation.

The motion did prevail with a vote of 15-0-0.

SB 818 (Schuitmaker) Education; occupational schools; occupational school regulations; exempt yoga teacher training programs.

Representative Yonker made a motion to report SB 818 with recommendation. The motion did prevail by a vote of 14-0-1.

Representative Hoadley came forward to join the presentation and speak to the committee members about a bill he is working on, HB 5013. Questions and discussions followed.

Joyce Young, representing the Michigan Organization of Nurse Executives and Trinity Health gave a presentation on nurse staffing but could not complete it because of time constraints.

There being no further business to come before the committee, the Chair adjourned the meeting the time being 1:20 p.m.
