OVERVIEW

As of May 21, FY 2009-10 supplemental appropriation requests from the State Budget Office (SBO) for funding to be received by departments other than the Department of Human Services (DHS) under the federal American Recovery and Reinvestment Act (ARRA) totaling \$138.2 million were pending before the Legislature. Additional ARRA requests were pending in the DHS budget.

The enacted version of Senate Bill 928 (Public Act 92 of 2010) contains appropriations reflecting all pending non-DHS ARRA requests (with a reduced funding amount for one item in the Community Health budget). The bill also includes a portion (\$60.4 million) of Food Assistance Program requests. Total appropriations in the bill are \$190.9 million, all funded from ARRA-related sources.

DEPARTMENT OF COMMUNITY HEALTH

1. Health Professional Students and Residents

Authorizes \$194,200 in federal funding from ARRA for a program that will match interested health professional students and residents with practice sites and clinical rotations on multidisciplinary health care teams in underserved communities. Eligible persons for the program include students enrolled in medical, physician assistant, nurse practitioner, dental and other primary care training programs, as well as primary care medical residents. Increases the Medical Services Administration line by \$15.0 million of federal ARRA authorization to expend federal grant funds awarded for the improvement of Michigan's electronic health information exchange. The four-year grant award will build upon the work of the Health Information Network and will move Michigan into the implementation phase of the sharing of electronic medical records. (3/18/10 SBO letter) <u>Senate Substitute</u> excludes this item. <u>House Substitute and Enacted Bill</u> include the \$7.0 million of the total \$15.0 million requested by SBO that correspond to activities to be administered by the Department for planning, integration of the State's public health reporting and surveillance systems and MCIIR with the Michigan Health Information Network (MiHN) Shared Services. Funds will also be used for outreach, education and grant management.

Increases federal ARRA FMAP authorization by \$11.4 million recognizing federal grant funds to extend the Qualified Individual (QI) program. The QI program reimburses for certain low-income elders or adults with disabilities for whom the Medicaid program pays their Medicare Part B premiums. The ARRA extends this program until December 31, 2010. (3/18/10 SBO letter)

Coping strategies and emotional support will be provided to help participants better manage personal health. Aging, public health and Medicaid agencies will collaborate on this project. <p>The ARRA appropriated \$4.5 billion for energy delivery and reliability activities, setting aside \$100.0 million for worker training. The state's allocation is \$4,388,025. The U.S. Department of Energy developed two grants programs for activities that (1) develop new training strategies and programs from the electric power system, and (2) providing training for workers within the electricity industry necessary to transition to a Smart Grid electricity transmission and delivery system. The award to DELEG, under this second grant program. (NMU received an award of \$673,462, not appropriated here, under the first grant program.) In addition to the ARRA grant, the project is augmented with in-kind support from the utilities industry (primarily Consumers Energy and DTE Energy) totaling \$16.8 million. The program aims to train 588 workers through pre-assessments, basic training, apprenticeships, and incumbent worker training, with training provided by area community colleges, labor organizations, and utilities. The goals of the program, developed under the aegis of the Michigan Utility Workforce Development Consortium include (1) training workers and creating career pathways in skilled trades and other in-demand jobs in the electricity sector; (2) meeting the needs of employers for highly skilled workers in the electricity sector, and (3) improving the preparedness of both new hires and incumbent workers within the electricity sector to migrate to the Smart Grid. Funding is allocated among five Michigan Works! Agencies (MWAs) based on the training needs of the utilities - Capital Area, Great Lakes Bay, Macomb/St. Clair, Oakland, and Southeast Michigan Community Alliance. (4/19/10 SBO letter)</p>

<p>Increases federal funding for food assistance program by \$112.7 million to increase caseload by 34,860 to 869,000 cases at an average monthly benefit of \$269.42. Also transfers \$81.5 million from the food assistance program benefits line item to food assistance program benefits (ARRA) line item to reflect a higher proportion of food assistance paid as a result of the enhanced ARRA benefit level. (2/11/10 SBO letter) <u>Senate and House Substitutes</u> include \$17.8 million of total SBO request with the intent to provide sufficient appropriations through early summer.</p>

On average, this group of FAP cases will see a monthly benefit increase of \$88. (2/11/10 SBO letter) <u>House Substitute</u> includes this item. <u>Enacted Bill</u> does not include this item.</p>

Provides \$6.5 million in federal ARRA funds for expanding and deploying three Homeland Security Teams to combat rural crime in 37 northern Michigan counties. The grant award period is from October 1, 2009 to July 31, 2011. These funds will pay for salary and equipment costs for the three teams. (3/18/10 SBO letter)

TRANSPORTATION**11. State Trunkline Road and Bridge, Blue Water Bridge Plaza Expansion**

Part of the transportation funding available to Michigan under the American Recovery and Reinvestment Act (ARRA) of 2009 was distributed by formula and appropriated through House Bill 4582 (2009 PA 3). Additional ARRA funding was available through the discretionary Transportation Investment Generating Economic Recovery (TIGER) grant program. In February 2010, Michigan was awarded two TIGER grants, including a \$30.0 million grant for use on the I-94/I69 Black River Bridge replacement project in Port Huron. This project is one element in the much larger Blue Water Bridge Plaza Expansion project. (3/18/10 SBO letter)

12. Transportation Economic Development, M-1 Rail

Michigan also received a \$25.0 million TIGER grant related to the M-1 rail project – a proposed 3.4 mile light rail project along Woodward Avenue (State trunkline route M-1) in downtown Detroit. The Governor's proposed FY 2010-11 transportation budget includes an appropriation of \$1.0 million in state funding from the Transportation Economic Development Fund for the M-1 project. 13. High Speed Rail Passenger

Michigan was awarded funding under an ARRA high-speed rail grant program. The funding will support renovation of an existing rail passenger station in Battle Creek, the construction of a platform and an Amtrak station for the Troy/Birmingham Multi-modal Transit Center, and the construction of a platform and a station for Amtrak services in Dearborn. (3/18/10 SBO letter.) Note: Department has informally requested increase to \$40,310,300 to reflect more up-to-date information on the award amount. House Substitute and Enacted Bill include the requested increase.

14. Non-Urban Operating/Capital (ARRA)

The original formula distribution of federal ARRA funds included in 2009 PA 3 included \$211.8 million for local road jurisdictions. As part of the local federal aid planning process, some local units elected to "flex" these funds for local transit projects. [The option to flex certain federal highway program funds for local transit projects is available under the current non-ARRA federal aid program.] The Federal Highway Administration (FHWA) has approved the state's request, on behalf of local units, to flex a total of \$524,100 in FHWA ARRA funds to local transit projects for capital equipment and facility renovations. The specific projects are as follows:
