- 7 and supervised in the community.
- 8 (s) "Offender who would likely be sentenced to imprisonment"
- 9 means either of the following:
- 10 (i) A felon or misdemeanant who receives a sentencing
- 11 disposition that appears to be in place of incarceration in a state
- 12 correctional facility or jail, according to historical local
- 13 sentencing patterns.
- 14 (ii) A currently incarcerated felon or misdemeanant who is
- 15 granted early release from incarceration to a community corrections
- 16 program or who is granted early release from incarceration as a
- 17 result of a community corrections program.
- (t) "Programmatic success" means that the department program
- 19 or initiative has ensured that the offender has accomplished all of

- 11 Sec. 204. The department shall use the internet to fulfill the
- 12 reporting requirements of this part. This requirement may include
- 13 transmission of reports via electronic mail to the recipients
- 14 identified for each reporting requirement or it may include
- 15 placement of reports on an internet or intranet site.
- 16 Sec. 205. Funds appropriated in part 1 shall not be used for
- 17 the purchase of foreign goods or services, or both, if
- 18 competitively priced and of comparable quality American goods or
- 19 services, or both, are available. Preference shall be given to
- 20 goods or services, or both, manufactured or provided by Michigan
- 21 businesses, if they are competitively priced and of comparable
- 22 quality. In addition, preference shall be given to goods or
- 23 services, or both, that are manufactured or provided by Michigan
- 24 businesses owned and operated by veterans, if they are
- 25 competitively priced and of comparable quality.
- 26 Sec. 206. The department shall not take disciplinary action
- 27 against an employee or a prisoner for communicating with a member



- 1 of the legislature or his or her staff.
- 2 Sec. 207. The department shall prepare a report on out-of-
- 3 state travel expenses not later than January 1 of each year. The
- 4 travel report shall be a listing of all travel by classified and
- 5 unclassified employees outside this state in the immediately
- 6 preceding fiscal year that was funded in whole or in part with
- 7 funds appropriated in the department's budget. The report shall be
- 8 submitted to the senate and house appropriations committees, the
- 9 senate and house fiscal agencies, and the state budget office. The
- 10 report shall include the following information:
- 11 (a) The dates of each travel occurrence.
- 12 (b) The total transportation and related costs of each travel
- 13 occurrence, including the proportion funded with state general
- 14 fund/general purpose revenues, the proportion funded with state
- 15 restricted revenues, the proportion funded with federal revenues,
- 16 and the proportion funded with other revenues.
- Sec. 208. Funds appropriated in part 1 shall not be used by
- 18 the department to hire a person to provide legal services that are
- 19 the responsibility of the attorney general. This prohibition does
- 20 not apply to legal services for bonding activities and for those
- 21 outside services that the attorney general authorizes.
- 22 Sec. 209. Not later than November 30, the state budget office
- 23 shall prepare and transmit a report that provides for estimates of
- 24 the total general fund/general purpose appropriation lapses at the
- 25 close of the prior fiscal year. This report shall summarize the
- 26 projected year-end general fund/general purpose appropriation
- 27 lapses by major departmental program or program areas. The report



- 1 shall be transmitted to the chairpersons of the senate and house
- 2 appropriations committees and the senate and house fiscal agencies.
- 3 Sec. 210. (1) In addition to the funds appropriated in part 1,
- 4 there is appropriated an amount not to exceed \$10,000,000.00 for
- 5 federal contingency funds. These funds are not available for
- 6 expenditure until they have been transferred to another line item
- 7 in part 1 under section 393(2) of the management and budget act,
- 8 1984 PA 431, MCL 18.1393.
- 9 (2) In addition to the funds appropriated in part 1, there is
- 10 appropriated an amount not to exceed \$10,000,000.00 for state
- 11 restricted contingency funds. These funds are not available for
- 12 expenditure until they have been transferred to another line item
- in part 1 under section 393(2) of the management and budget act,
- 14 1984 PA 431, MCL 18.1393.
- 15 (3) In addition to the funds appropriated in part 1, there is
- appropriated an amount not to exceed \$2,000,000.00 for local
- 17 contingency funds. These funds are not available for expenditure
- 18 until they have been transferred to another line item in part 1
- 19 under section 393(2) of the management and budget act, 1984 PA 431,
- **20** MCL 18.1393.
- 21 (4) In addition to the funds appropriated in part 1, there is
- appropriated an amount not to exceed \$2,000,000.00 for private
- 23 contingency funds. These funds are not available for expenditure
- 24 until they have been transferred to another line item in part 1
- 25 under section 393(2) of the management and budget act, 1984 PA 431,
- **26** MCL 18.1393.
- 27 Sec. 211. The department shall cooperate with the department



- 1 of technology, management, and budget to maintain a searchable
- 2 website accessible by the public at no cost that includes, but is
- 3 not limited to, all of the following for the department:
- 4 (a) Fiscal year-to-date expenditures by category.
- 5 (b) Fiscal year-to-date expenditures by appropriation unit.
- 6 (c) Fiscal year-to-date payments to a selected vendor,
- 7 including the vendor name, payment date, payment amount, and
- 8 payment description.
- **9** (d) The number of active department employees by job
- 10 classification.
- 11 (e) Job specifications and wage rates.
- 12 Sec. 212. Within 14 days after the release of the executive
- 13 budget recommendation, the department shall cooperate with the
- 14 state budget office to provide the chairpersons of the senate and
- 15 house appropriations committees, the chairpersons of the senate and
- 16 house appropriations subcommittees on corrections, and the senate
- 17 and house fiscal agencies with an annual report on estimated state
- 18 restricted fund balances, state restricted fund projected revenues,
- 19 and state restricted fund expenditures for the prior 2 fiscal
- 20 years.
- 21 Sec. 213. The department shall maintain, on a publicly
- 22 accessible website, a department scorecard that identifies, tracks,
- 23 and regularly updates key metrics that are used to monitor and
- 24 improve the department's performance.
- 25 Sec. 214. Total authorized appropriations from all sources
- 26 under part 1 for legacy costs for the fiscal year ending September
- 27 30, 2020 are estimated at \$295,107,000.00. From this amount, total



- 1 department appropriations for pension-related legacy costs are
- 2 estimated at \$143,458,300.00. Total department appropriations for
- 3 retiree health care legacy costs are estimated at \$151,648,700.00.
- 4 Sec. 216. (1) On a quarterly basis, the department shall
- 5 report on the number of full-time equated positions in pay status
- 6 by civil service classification, including the number of full-time
- 7 equated positions in pay status by civil service classification for
- 8 each correctional facility, to the senate and house appropriations
- 9 subcommittees on corrections, the senate and house fiscal agencies,
- 10 the legislative corrections ombudsman, and the state budget office.
- 11 This report must include the following:
- 12 (a) A detailed accounting of all vacant positions that exist
- 13 within the department.
- 14 (b) A detailed accounting of all correction officer positions
- 15 at each correctional facility, including positions that are filled
- 16 and vacant positions, by facility.
- 17 (c) A detailed accounting of all vacant positions that are
- 18 health care-related.
- 19 (d) A detailed accounting of vacant positions that are being
- 20 held open for temporarily nonactive employees.
- 21 (2) As used in this section, "vacant position" means any
- 22 position that has not been filled at any time during the past 12
- 23 calendar months.
- Sec. 219. (1) Any contract for prisoner telephone services
- 25 entered into after the effective date of this section shall include
- 26 a condition that fee schedules for prisoner telephone calls,
- 27 including rates and any surcharges other than those necessary to



- 1 meet program and special equipment costs, be the same as fee
- 2 schedules for calls placed from outside of correctional facilities.
- 3 (2) Revenues appropriated and collected for program and
- 4 special equipment funds shall be considered state restricted
- 5 revenue. Funding shall be used for prisoner programming, special
- 6 equipment, and security projects. Unexpended funds remaining at the
- 7 close of the fiscal year shall not lapse to the general fund but
- 8 shall be carried forward and be available for appropriation in
- 9 subsequent fiscal years.
- 10 (3) The department shall submit a report to the senate and
- 11 house appropriations subcommittees on corrections, the senate and
- 12 house fiscal agencies, the legislative corrections ombudsman, and
- 13 the state budget office by February 1 outlining revenues and
- 14 expenditures from program and special equipment funds. The report
- 15 shall include all of the following:
- 16 (a) A list of all individual projects and purchases financed
- 17 with program and special equipment funds in the immediately
- 18 preceding fiscal year, the amounts expended on each project or
- 19 purchase, and the name of each vendor from which the products or
- 20 services were purchased.
- 21 (b) A list of planned projects and purchases to be financed
- 22 with program and special equipment funds during the current fiscal
- 23 year, the amounts to be expended on each project or purchase, and
- 24 the name of each vendor from which the products or services will be
- 25 purchased.
- (c) A review of projects and purchases planned for future
- 27 fiscal years from program and special equipment funds.



- 1 Sec. 220. The department may charge fees and collect revenues



Allowable uses of drunk driver jail reduction and community treatment program funding shall include reimbursing counties for transportation, treatment costs, and housing drunk drivers during a period of assessment for treatment and case planning. - 6 success administration, the department shall collaborate with the
- 7 Michigan Restaurant Association for job placement for individuals
- 8 on probation and parole.
- 9 Sec. 425. (1) From the funds appropriated in part 1 for
- 10 offender success programming, \$1,000,000.00 shall be used by the
- 11 department to establish medication-assisted treatment offender
- 12 success pilot programs to provide prerelease treatment and
- 13 postrelease referral for opioid-addicted and alcohol-addicted
- 14 offenders who voluntarily participate in the medication-assisted

- 26 inmate's current treatment plan including any medications that are
- 27 currently prescribed to the inmate.




FIELD OPERATIONS ADMINISTRATION

- 2 Sec. 603. (1) All prisoners, probationers, and parolees
- 3 involved with the curfew monitoring program shall reimburse the
- 4 department for costs associated with their participation in the
- 5 program. The department may require community service work
- 6 reimbursement as a means of payment for those able-bodied
- 7 individuals unable to pay for the costs of the equipment.
- 8 (2) Program participant contributions and local program
- 9 reimbursement for the curfew monitoring program appropriated in
- 10 part 1 are related to program expenditures and may be used to
- 11 offset expenditures for this purpose.
- 12 (3) Included in the appropriation in part 1 is adequate
- 13 funding to implement the curfew monitoring program to be
- 14 administered by the department. The curfew monitoring program is
- 15 intended to provide sentencing judges and county sheriffs in
- 16 coordination with local community corrections advisory boards
- 17 access to the state's curfew monitoring program to reduce prison
- 18 admissions and improve local jail utilization. The department shall
- 19 determine the appropriate distribution of the curfew monitor units
- 20 throughout the state based upon locally developed comprehensive
- 21 corrections plans under the community corrections act, 1988 PA 511,
- 22 MCL 791.401 to 791.414.
- 23 (4) For a fee determined by the department, the department
- 24 shall provide counties with the curfew monitor equipment,
- 25 replacement parts, administrative oversight of the equipment's

- 2 Sec. 611. The department shall prepare by March 1 individual
- 3 reports for the residential reentry program, the electronic
- 4 monitoring program, and the special alternative to incarceration
- 5 program. The reports shall be submitted to the senate and house
- 6 appropriations subcommittees on corrections, the senate and house
- 7 fiscal agencies, the legislative corrections ombudsman, and the
- 8 state budget office. Each program's report shall include
- 9 information on all of the following:
- 10 (a) Monthly new participants by type of offender. Residential

- 27 (j) Analysis of the impact on prison admissions and jail



- 1 utilization and the cost effectiveness of the program.
- 2 Sec. 612. (1) The department shall review and revise as
- 3 necessary policy proposals that provide alternatives to prison for
- 4 offenders being sentenced to prison as a result of technical
- 5 probation violations and technical parole violations. To the extent
- 6 the department has insufficient policies or resources to affect the
- 7 continued increase in prison commitments among these offender
- 8 populations, the department shall explore other policy options to
- 9 allow for program alternatives, including department or OCC-funded
- 10 programs, local level programs, and programs available through
- 11 private agencies that may be used as prison alternatives for these
- 12 offenders.
- 13 (2) By April 1, the department shall provide a report to the

- 16 Sec. 613. When the department is determining where to place a
- 17 parolee with chronic technical violations, the department shall
- 18 give priority to placing a parolee in an intensive detention
- 19 program that offers specific programming to address the behavioral
- 20 needs of the parolee, and that works on a plan with the parolee to
- 21 ensure that once the parolee is released he or she can remain in
- 22 the community and successfully complete his or her parole.
- 23 Sec. 615. (1) The department shall submit a report detailing

- 12 residential alternative to prison program, the department shall
- 13 provide vocational, educational, and cognitive programming in a
- 14 secure environment to enhance existing alternative sentencing
- 15 options, increase employment readiness and successful placement
- 16 rates, and reduce new criminal behavior for the west Michigan
- 17 probation violator population. The department shall measure and set
- 18 the following metric goals:
- 19 (a) 85% of participants successfully complete the program.
- 20 (b) Of the participants that complete the program, 75% will
- 21 earn a nationally recognized credential for career and vocational



- 2 Sec. 802. As a condition of expenditure of the funds
- 3 appropriated in part 1, the department shall provide the senate and
- 4 house appropriations subcommittees on corrections, the senate and
- 5 house fiscal agencies, the legislative corrections ombudsman, and
- 6 the state budget office with quarterly reports on physical and
- 7 mental health care detailing quarterly and fiscal year-to-date
- 8 expenditures itemized by vendor, allocations, status of payments
- 9 from contractors to vendors, and projected year-end expenditures
- 10 from accounts for prisoner health care, mental health care,
- 11 pharmaceutical services, and durable medical equipment. These
- 12 reports shall include a breakdown of all payments to the integrated
- 13 care provider itemized by physical health care, mental health care,
- 14 and pharmacy expenditures.
- 15 Sec. 803. (1) The department shall assure that all prisoners,
- 16 upon any health care treatment, are given the opportunity to sign a
- 17 release of information form designating a family member or other
- 18 individual to whom the department shall release records information
- 19 regarding a prisoner. A release of information form signed by a
- 20 prisoner shall remain in effect for 1 year, and the prisoner may
- 21 elect to withdraw or amend the release form at any time.
- 22 (2) The department shall assure that any such signed release
- 23 forms follow a prisoner upon transfer to another department
- 24 facility or to the supervision of a parole officer.
- 25 (3) The form shall be placed online, on a public website

- 4 The report shall include the number of inpatient hospital days,
- 5 outpatient visits, emergency room visits, and prisoners receiving
- 6 off-site inpatient medical care in the previous quarter, by
- 7 facility.
- 8 Sec. 807. The funds appropriated in part 1 for Hepatitis C
- 9 treatment shall be used only to purchase specialty medication for
- 10 Hepatitis C treatment in the prison population. In addition to the
- 11 above appropriation, any rebates received from the medications used
- 12 shall be used only to purchase specialty medication for Hepatitis C
- 13 treatment. On a quarterly basis, the department shall issue a
- 14 report to the senate and house appropriations subcommittees on
- 15 corrections, the senate and house fiscal agencies, the legislative
- 16 corrections ombudsman, and the state budget office, showing for the
- 17 previous 4 quarters the total amount spent on specialty medication

- Sec. 812. (1) The department shall provide the department of
- 23 health and human services with a monthly list of prisoners newly

- 26 interagency agreement under which the department of health and
- 27 human services provides the department of corrections with monthly



- 1 lists of newly committed prisoners who are eligible for Medicaid

- 2 part of the program.
- **3** Sec. 903a. From the funds appropriated in part 1 for prison

- 17 (a) The number of instructors and the number of instructor
- 18 vacancies, by program and facility.
- 19 (b) The number of prisoners enrolled in each program, the
- 20 number of prisoners completing each program, the number of
- 21 prisoners who do not complete each program and are not subsequently
- 22 reenrolled, and the reason for not completing the program, the
- 23 number of prisoners transferred to another facility while enrolled
- 24 in a program and not subsequently reenrolled, the number of
- 25 prisoners enrolled who are repeating the program, and the number of
- 26 prisoners on waiting lists for each program, all itemized by
- 27 facility.



- (c) The steps the department has undertaken to improve
 programs, track records, accommodate transfers and prisoners with
 health care needs, and reduce waiting lists.
- 4 (d) The number of prisoners paroled without a high school
 5 diploma and the number of prisoners paroled without a high school
 6 equivalency.
- (e) An explanation of the value and purpose of each program,
 for example, to improve employability, reduce recidivism, reduce
 prisoner idleness, or some combination of these and other factors.
- 10 (f) An identification of program outcomes for each academic
 11 and vocational program.
- (g) The number of prisoners not paroled at their earliest
 release date due to lack of a high school equivalency, and the
 reason those prisoners have not obtained a high school equivalency.
- Sec. 910. The department shall allow the Michigan Braille
 transcribing fund program to operate at its current location. The
 donation of the building by the Michigan Braille transcribing fund
 at the G. Robert Cotton Correctional Facility in Jackson is
 acknowledged and appreciated. The department shall continue to
 encourage the Michigan Braille transcribing fund program to produce
 high-quality materials for use by the visually impaired.
- Sec. 911. By March 1, the department shall report to the
 senate and house appropriations subcommittees on corrections, the
 senate and house fiscal agencies, the legislative corrections
 ombudsman, and the state budget office the number of critical
 incidents occurring each month by type and the number and severity
 of assaults, escape attempts, suicides, and attempted suicides

- 1 occurring each month at each facility during the immediately
- 2 preceding calendar year.
- 3 Sec. 912. The department shall report monthly to the senate
- 4 and house appropriations subcommittees on corrections, the senate
- 5 and house fiscal agencies, the legislative corrections ombudsman,
- 6 and the state budget office on the ratio of correctional officers
- 7 to prisoners for each correctional institution, the ratio of shift
- 8 command staff to line custody staff, and the ratio of noncustody
- 9 institutional staff to prisoners for each correctional institution.
- 10 Sec. 913. (1) From the funds appropriated in part 1, the
- 11 department shall focus on providing required programming to
- 12 prisoners who are past their earliest release date because of not
- 13 having received the required programming. Programming includes, but
- 14 is not limited to, violence prevention programming, assaultive
- 15 offender programming, sexual offender programming, substance abuse
- 16 treatment programming, thinking for a change programming, and any
- 17 other programming that is required as a condition of parole.
- 18 (2) It is the intent of the legislature that any prisoner
- 19 required to complete a violence prevention program, sexual offender
- 20 program, or other program as a condition of parole shall be placed
- 21 on a waiting list for the appropriate programming upon entrance to
- 22 prison and transferred to a facility where that program is
- 23 available in order to accomplish timely completion of that program
- 24 prior to the expiration of his or her minimum sentence and
- 25 eligibility for parole. Nothing in this section should be deemed to
- 26 make parole denial appealable in court.
- 27 (3) The department shall submit a quarterly report to the




- 1 senate and house appropriations subcommittees on corrections, the
- 2 senate and house fiscal agencies, the legislative corrections
- 3 ombudsman, and the state budget office detailing enrollment in sex
- 4 offender programming, assaultive offender programming, violent
- 5 offender programming, and thinking for a change programming. At a
- 6 minimum, the report shall include the following:
- 7 (a) A full accounting, from the date of entrance to prison, of
- 8 the number of individuals who are required to complete the
- 9 programming, but have not yet done so.
- 10 (b) The number of individuals who have reached their earliest
- 11 release date, but who have not completed required programming.
- 12 (c) A plan of action for addressing any waiting lists or
- 13 backlogs for programming that may exist.
- 14 Sec. 920. If a female prisoner consents to a visitor being
- 15 present, the department shall allow that 1 person to be present
- 16 during the prisoner's labor and delivery. The person allowed to
- 17 accompany the prisoner must be an immediate family member, legal
- 18 guardian, spouse, or domestic partner. The department is authorized
- 19 to deny access to a visitor if the department has a safety concern
- 20 with that visitor's access. The department is authorized to conduct
- 21 a criminal background check on a visitor.
- 22 Sec. 924. The department shall evaluate all prisoners at
- 23 intake for substance abuse disorders, serious developmental
- 24 disorders, serious mental illness, and other mental health
- 25 disorders. Prisoners with serious mental illness or serious
- 26 developmental disorders shall not be removed from the general
- 27 population as a punitive response to behavior caused by their



- 1 serious mental illness or serious developmental disorder. Due to
- 2 persistent high violence risk or severe disruptive behavior that is
- 3 unresponsive to treatment, prisoners with serious mental illness or
- 4 serious developmental disorders may be placed in secure residential
- 5 housing programs that will facilitate access to institutional
- 6 programming and ongoing mental health services. A prisoner with
- 7 serious mental illness or serious developmental disorder who is
- 8 confined in these specialized housing programs shall be evaluated
- 9 or monitored by a medical professional at a frequency of not less
- 10 than every 12 hours.
- 11 Sec. 925. By March 1, the department shall report to the
- 12 senate and house appropriations subcommittees on corrections, the
- 13 senate and house fiscal agencies, the legislative corrections
- 14 ombudsman, and the state budget office on the annual number of
- 15 prisoners in administrative segregation between October 1, 2018 and
- 16 September 30, 2019, and the annual number of prisoners in
- 17 administrative segregation between October 1, 2018 and September
- 18 30, 2019 who at any time during the current or prior prison term
- 19 were diagnosed with serious mental illness or have a developmental
- 20 disorder and the number of days each of the prisoners with serious
- 21 mental illness or a developmental disorder have been confined to
- 22 administrative segregation.
- Sec. 929. From the funds appropriated in part 1, the
- 24 department shall do all of the following:
- 25 (a) Ensure that any inmate care and control staff in contact
- 26 with prisoners less than 18 years of age are adequately trained
- 27 with regard to the developmental and mental health needs of



- 1 prisoners less than 18 years of age. By April 1, the department
- 2 shall report to the senate and house appropriations subcommittees
- 3 on corrections, the senate and house fiscal agencies, the
- 4 legislative corrections ombudsman, and the state budget office on
- 5 the training curriculum used and the number and types of staff
- 6 receiving annual training under that curriculum.
- 7 (b) Provide appropriate placement for prisoners less than 18
- 8 years of age who have serious mental illness, serious emotional
- 9 disturbance, or a serious developmental disorder and need to be
- 10 housed separately from the general population. Prisoners less than
- 11 18 years of age who have serious mental illness, serious emotional
- 12 disturbance, or a serious developmental disorder shall not be
- 13 removed from an existing placement as a punitive response to
- 14 behavior caused by their serious mental illness, serious emotional
- 15 disturbance, or a serious developmental disorder. Due to persistent
- 16 high violence risk or severe disruptive behavior that is
- 17 unresponsive to treatment, prisoners less than 18 years of age with
- 18 serious emotional disturbance, serious mental illness, or serious
- 19 developmental disorders may be placed in secure residential housing
- 20 programs that will facilitate access to institutional programming
- 21 and ongoing mental health services. A prisoner less than 18 years
- 22 of age with serious mental illness, serious emotional disturbance,
- 23 or a serious developmental disorder who is confined in these
- 24 specialized housing programs shall be evaluated or monitored by a
- 25 medical professional at a frequency of not less than every 12
- 26 hours.
- 27 (c) Implement a specialized offender success program that



- 1 recognizes the needs of prisoners less than 18 years old for
- 2 supervised offender success.
- 3 Sec. 930. The department shall submit a quarterly report to
- 4 the senate and house appropriations subcommittees on corrections,
- 5 the senate and house fiscal agencies, the legislative corrections
- 6 ombudsman, and the state budget office on the number of youth in
- 7 prison. The report shall include, but not be limited to, the
- 8 following information:
- **9** (a) The total number of inmates under age 18 who are not on
- 10 Holmes youthful trainee act status.
- 11 (b) The total number of inmates under age 18 who are on Holmes
- 12 youthful trainee act status.
- 13 (c) The total number of inmates aged 18 to 23 who are on
- 14 Holmes youthful trainee act status.
- Sec. 940. (1) Any lease, rental, contract, or other legal
- 16 agreement that includes a provision allowing a private person or
- 17 entity to use state-owned facilities or other property to conduct a
- 18 for-profit business enterprise shall require the lessee to pay fair
- 19 market value for the use of the state-owned property.
- 20 (2) The lease, rental, contract, or other legal agreement
- 21 shall also require the party using the property to make a payment
- 22 in lieu of taxes to the local jurisdictions that would otherwise
- 23 receive property tax revenue, as if the property were not owned by
- 24 the state.
- 25 Sec. 942. The department shall ensure that any contract with a
- 26 public or private party to operate a facility to house state
- 27 prisoners includes a provision to allow access by both the office



- 1 of the legislative auditor general and the office of the
- 2 legislative corrections ombudsman to the facility and to
- 3 appropriate records and documents related to the operation of the
- 4 facility. These access rights for both offices shall be the same
- 5 for the contracted facility as for a general state-operated
- 6 correctional facility.
- 7 Sec. 943. The department shall submit a report by May 1 to the
- 8 senate and house appropriations subcommittees on corrections, the
- 9 senate and house fiscal agencies, the legislative corrections
- 10 ombudsman, and the state budget office on the actual and projected
- 11 savings achieved by closing correctional facilities. Savings
- 12 amounts shall be itemized by facility. Information required by this
- 13 section shall start with the closure of the Pugsley Correctional
- 14 Facility, which closed in September of 2016.
- 15 Sec. 944. When the department is planning to close a
- 16 correctional facility, the department shall fully consider the
- 17 potential economic impact of the prison closure on the community
- 18 where the facility is located. The department, when weighing all
- 19 factors related to the closure of a facility, shall also consider
- 20 the impact on the local community where the facility to be closed
- 21 is located.

22 MISCELLANEOUS

- Sec. 1009. The department shall make an information packet for
- 24 the families of incoming prisoners available on the department's
- 25 website. The information packet shall be updated by February 1. The
- 26 packet shall provide information on topics including, but not



- 1 limited to: how to put money into prisoner accounts, how to make
- 2 phone calls or create Jpay electronic mail accounts, how to visit
- 3 in person, proper procedures for filing complaints or grievances,
- 4 the rights of prisoners to physical and mental health care, how to
- 5 utilize the offender tracking information system (OTIS), truth-in-
- 6 sentencing and how it applies to minimum sentences, the parole
- 7 process, and guidance on the importance of the role of families in
- 8 the reentry process. The department is encouraged to partner with
- 9 external advocacy groups and actual families of prisoners in the
- 10 packet-writing process to ensure that the information is useful and
- 11 complete.
- Sec. 1011. The department may accept in-kind services and
- 13 equipment donations to facilitate the addition of a cable network
- 14 that provides programming that will address the religious needs of
- 15 incarcerated individuals. This network may be a cable television
- 16 network that presently reaches the majority of households in the
- 17 United States. A bilingual channel affiliated with this network may
- 18 also be added to department programming to assist the religious
- 19 needs of Spanish-speaking inmates. The addition of these channels
- 20 shall be at no additional cost to this state.
- 21 Sec. 1013. From the funds appropriated in part 1, priority may
- 22 be given to funding reentry or rehabilitation programs that have
- 23 been demonstrated to reduce prison violence and recidivism,
- 24 including faith-based initiatives.
