BACKGROUND AND SUMMARY OF PROPOSED RULES

Rule Set 2022-061 HS would add 14 new rules regarding the ST Elevated Myocardial Infarction (STEMI) statewide network. Specific items of the proposed rule set would include the following:

- Definitions.
- Rules regarding the powers and duties of the Department of Health and Human Services (DHHS) to establish a statewide STEMI system, regional systems of care, quality improvement program, and trainings. Additional responsibilities of the department include monitoring and developing procedures to maintain the statewide STEMI network.
- Rules regarding the department's right to deny, suspend, or revoke a facility's designation as a STEMI facility based on certain criteria.
- Rules regarding obtaining and maintaining a STEMI designation including data submission and participation in statewide STEMI network activities such as implementing STEMI risk reduction plans.
- Rules regarding triage and transport for regional STEMI systems including permitting regional facilities to create their own triage and transport protocols as long as certain criteria are met.
- Rules regarding commitment of support for regional STEMI systems, including the requirement of Medical Control Authority (MCA) participation in all regional STEMI systems. Additional rules require quarterly reports from regional STEMI systems.
- Rules regarding data collection and protocol development by DHHS with recommendations from the statewide STEMI care advisory subcommittee and state Emergency Medical Services (EMS) coordination committee.
- Rules regarding the development of a statewide STEMI registry to house data collected from regional STEMI systems.
- Rules requiring the establishment and implementation of a regional STEMI care performance improvement plan by each regional STEMI system.
- Rules requiring local MCAs to implement protocols for patient transportation for EMS as well as a systems of care protocol for STEMI facilities, following DHHS approval.
- Rules requiring STEMI facilities to contact DHHS for direction on transfer of a STEMI patient.

FISCAL IMPACT OF PROPOSED RULES

The FY 2023-24 DHHS budget includes \$2.0 million in ongoing funding and 7 additional FTEs to support the statewide STEMI system. 2022-061 HS could increase expenditures for the Department of

Health and Human Services (DHHS), but current appropriations should be sufficient to support these costs. This rule set should have not fiscal impact on local units of. The fiscal impact of 2022-061 HS would be dependent on the continued cost to implement and maintain a statewide STEMI system, data collection and presentation, facility designation process, as well as protocol creation and implementation.
