- Additional manuals: Brady/Giglio, Conflicts of Interest


Assistance


Adult & Juvenile Case Tracking (ACT)

- An outdated computer software system used by 76 of the 83 prosecutor's offices, and the Attorney General's office.
- Supports 1,400 users.
- Risk of becoming obsolete with each new Microsoft Windows Update.
- Used to generate all documents, warrants, subpoenas, and victim rights notices from an integrated database.
- Extremely limited remote access.
- Not secure by modern day standards.

Prosecutor NextGen


- Will replace ACT/JCT.
- CJIS Compliant and increased security against modern cyber attacks.
- Cloud based and accessible remotely.
- Allows for information to be shared across prosecutors' offices.
- Provides fast and up to do date discovery.
- Anticipated roll out starts December 2021.
- Can communicate with other criminal justice partners including courts, defense, MSP and MDOC.
