A. UNIVERSITY OPERATIONS

1. Budget Act Format

The FY 2008-09 Higher Education budget act had utilized the budget bill format initially used in FY 2007-08 that separated the act into four distinct articles. The FY 2009-10 act instead uses subparts within the line item section, allowing budget act boilerplate language to be reconsolidated into one part.

- Subpart A: Research universities (Michigan State, UM-Ann Arbor, Wayne State);
- Subpart B: State universities (remaining 12 universities); and
- Subpart C: State and regional programs, grants, and financial aid.

2. Operations Appropriation Adjustments

A reduction of \$46.6 million GF/GP, consistent with the Governor's budget proposal, is made across the 15 public university operations line items. Those reductions are partially offset with \$40.5 million in funding (available in FY 2009-10 only) from the Education portion of the State Fiscal Stabilization Fund (SFSF) under the American Recovery and Reinvestment Act (ARRA), consistent with the state's application to the U.S. Department of Education. The net result is a reduction of \$6.1 million—equating to a 0.4% net reduction to each university's operations line item.

Column 6 of <u>Table 1</u> lists the dollar amount each university receives. <u>Tables 2</u> through <u>4</u> outline the recommendations of the Governor, House, and Senate. <u>Table 5</u> shows per-student funding amounts for the 15 public universities.

B. INDIAN TUITION WAIVERS

In FY 1996-97, funding totaling \$2.5 million was added to the base appropriation for each university for costs incurred under Public Act 174 of 1976, the Indian Tuition Waiver Act. Over the last decade, costs paid by the 15 public universities for the tuition waivers have continued to increase and, in FY 2007-08, for the first time since FY 1996-97, an appropriation to the universities of \$1.4 million was made explicitly to offset some of the increased costs. This new appropriation resulted in a total FY 2007-08 Indian Tuition Waiver allocation of \$3.9 million. Table 6 lists, for each university, the FY 1996-97 tuition waiver amount added to the base, the FY 2007-08 allocation amount, an adjustment for across-the-board changes to university appropriations in FYs 2008-09 and 2009-10, and the resulting total FY 2009-10 Indian Tuition Waiver allocation. Note that these calculations reflect historical appropriation adjustments related to the Indian Tuition Waiver program, but that the budget act does not contain language formally allocating the funds for the waiver program.

For the last several years, an allocation of \$100,000 has been included in Lake Superior State's appropriation to be passed through to Bay Mills Tribal College to partially fund waiver costs at that college. (Tribal colleges are included in the statute establishing the waiver. The allocation for Bay Mills was previously included in Northern Michigan's appropriation.) For FY 2009-10, a similar allocation was included in Central Michigan's appropriation to be passed through to Saginaw Chippewa Tribal College. The allocation amount of \$29,700 was prorated based on the relative enrollments of the two tribal colleges.

C. MARTIN LUTHER KING, JR.-CESAR CHAVEZ-ROSA PARKS INITIATIVE

There were no policy changes for the six King-Chavez-Parks (KCP) Programs for FY 2009-10. <u>Table 7</u> provides an overview of funding for the \$5.2 million initiative. <u>Table 8</u> lists the dollar amounts for each university for the College Day, Future Faculty, and Visiting Professors Programs; the dollar amounts reflect the FY 2009-10 net reduction of 0.4% for each program, consistent with the change in overall university appropriations.

The Governor had proposed to eliminate all components of the KCP Programs. Both the stand-alone competitive grant components and the components allocated in university appropriations were retained in the final version of the budget—due, in part, to the availability of SFSF revenue under ARRA to partially offset university appropriation reductions.

D. AGRICULTURAL EXPERIMENT STATION AND COOPERATIVE EXTENSION SERVICE

The Agricultural Experiment Station (AES) and the Cooperative Extension Service (CES) are agricultural economic programs operated by Michigan State University that provide services throughout the State. A reduction of \$32.0 million GF/GP, consistent with the Governor's budget proposal, is made to the two line items. That reduction is partially offset, however, with \$27.8 million in funding (available in FY 2009-10 only) from the Education portion of the SFSF under ARRA (consistent with the state's application to U.S. Department of Education), and \$3.9 million GF/GP is added to equalize the net reduction to the line items with the net reductions to university operations line items at 0.4%. The net reduction to line items totals \$255,800.

E. HIGHER EDUCATION DATABASE

The appropriation for the maintenance of the state's higher education institutional data inventory (HEIDI), to which the 15 public universities annually submit enrollment and financial data for use by state policy makers, is reduced from \$200,000 to \$105,000 GF/GP.

F. FINANCIAL AID CONSOLIDATION PROPOSAL

The Executive Recommendation had proposed to consolidate funding, with a net reduction of \$18.8 million, for the State Competitive Scholarship, Tuition Grant, Michigan Work Study, Part-Time Independent Student, Michigan Education Opportunity Grant, and Nursing Scholarship Programs into an appropriation for a single need-based financial aid program. The consolidation proposal was not adopted under the House, Senate, or Enacted versions of the budget, although funding for all the listed programs was reduced or eliminated.

G. STATE COMPETITIVE SCHOLARSHIPS

Public Act 208 of 1964 created the State Competitive Scholarship Program, which provides grants to students who score well on the American College Test (ACT) and have financial need. The appropriation for the program is reduced by 50.4%, from \$35.5 million to \$17.6 million. (Note: Overall financial aid reductions in the FY 2009-10 budget may affect the state's ability to receive a portion of the \$2.9 million in federal funds currently used to supplement state funding for Competitive Scholarships. The remaining \$14.7 million is appropriated from GF/GP revenue.)

H. TUITION GRANTS

Public Act 313 of 1966 created the Tuition Grant Program, which provides grants to students with financial need enrolled at the independent colleges and universities. The appropriation for the program is reduced by 44.1%, from \$56.7 million to \$31.7 million. Two program policy changes are included in associated boilerplate language: elimination of graduate student eligibility and inclusion of a \$3.0 million cap on the amount of grant awards that can be received by students at any one independent institution. Based on historical data, the second change will impact students at Baker College and Davenport University.

I. SMALLER NEED-BASED PROGRAMS

Appropriations totaling \$12.1 million GF/GP for three need-based financial aid programs administered on a campus-level basis are eliminated in the FY 2009-10 Higher Education budget:

- \$7.3 million for the Michigan Work Study Program (Public Acts 288 and 303 of 1986).
- \$2.7 million for the Part-Time Independent Student Program (Public Act 102 of 1986).
- \$2.1 million for the Michigan Education Opportunity Grant Program (Public Act 273 of 1986).

J. NURSING SCHOLARSHIP PROGRAM

Public Act 591 of 2002 created the Nursing Scholarship Program, which provides financial aid awards to nursing students agreeing to pursue careers as nurses in Michigan. The FY 2009-10 Higher Education budget eliminates funding for this program. The FY 2008-09 appropriation for the program was \$4.25 million (Merit Award Trust Fund).

K. MICHIGAN MERIT AWARDS

Public Act 94 of 1999 created the Michigan Merit Award Program, which provided merit-based grants of up to \$3,000 to students who scored well on the middle school and high school MEAP test or Merit Exam. The high school class of 2000 was the first eligible graduating class and the class of 2006 was the last. For FY 2009-10, only a \$100 placeholder appropriation is included in the budget, in the event that additional costs of awards to students from prior high school classes are identified and a legislative transfer is needed.

L. MICHIGAN PROMISE GRANTS

Public Act 479 of 2006 created the Michigan Promise Grant Program to provide merit-based grants of up to \$4,000 to students who score well on the high school Merit Exam and/or who complete two years of postsecondary education with at least a 2.5 grade point average. This program replaced the Merit Award Program beginning with the high school class of 2007. The Executive Recommendation for FY 2009-10 included an appropriation of \$140.0 million (Merit Award Trust Fund) for the program—approximately \$70.0 million for the \$1,000 biennial grants (\$1,000 per year for the first two years of study) for students enrolled in college who scored well on the Michigan Merit Exam and \$70.0 million for the costs of the \$2,000/\$4,000 grants paid after completion of two years of postsecondary education that were to begin in FY 2009-10.

More recent data indicate the FY 2009-10 costs of the back-end awards would have been substantially lower than was originally projected. Total program costs would have been slightly under \$100.0 million in FY 2009-10—with costs increasing to a long-run annual total of roughly \$180.0 million over the next 3-5 years.

The version of the FY 2009-10 Higher Education budget signed into law does not include an appropriation for the Promise Grant Program. Neither the exam-based award payments (2008 and 2009 high school classes) nor the back-end award payments (2007 high school class) will be paid to students.

M. TUITION INCENTIVE PROGRAM (TIP)

Due to a continued increase in Tuition Incentive Program (TIP) students attending college, the appropriation for TIP is increased by \$6.0 million from the initial FY 2008-09 appropriation for the program. The program provides an incentive to Medicaid-eligible middle school and high school students by promising to pay for certain postsecondary tuition costs if they graduate from high school. It pays for two years of associate's-degree-level tuition costs and up to an additional \$2,000 toward a bachelor's degree. The FY 2009-10 TIP appropriation is \$31.2 million, financed from \$30.1 million in Merit Award Trust Fund revenue and \$1.1 million in State GF/GP revenue.

N. PROJECT GEAR-UP

The appropriation for Project GEAR-UP, a federally-funded scholarship program for students who have participated in college-exposure programs beginning in middle school, is reduced from \$3.0 million to \$1.5 million to more accurately reflect available funding.

O. MAJOR FUNDING-RELATED BOILERPLATE CHANGES

- 1. **Postsecondary Student Data System.** Language is included requiring universities to cooperate with state measures to meet ARRA requirements to develop a P-16 longitudinal data system. (Sec. 216)
- 2. **Tuition Grants.** Graduate student eligibility is eliminated and a cap of \$3.0 million is imposed on the amount of grant awards that can be received by students at any single institution. (Sec. 302)
- 3. **Financial Aid Workgroup.** Intent language is added for workgroup that includes legislators and higher education organizations to examine and make recommendations regarding state financial aid programs. (Sec. 316)
- 4. **Financial Aid Funding Intent.** Language is added stating intent that, if economy improves and state revenues increase, Tuition Grants, Promise Grants, and other financial aid programs are among the foremost priorities in the Higher Education budget. (Secs. 317, 318, 319)
- 5. **Bioeconomy Research.** Language regarding the appropriations for the Agricultural Experiment Station and Cooperative Extension Service is revised to state intent that, if funding levels for the programs are restored, up to \$3.5 million be expended for bioeconomy research. (Sec. 433)

- 6. **Future Farmers of America.** Allocation of \$80,000 from Michigan State University's operations appropriation for the Michigan Future Farmers of America Association is retained. (Sec. 434)
- 7. **State Fiscal Stabilization Fund Revenue.** Language regarding tuition restraint is replaced with new language stating that funds appropriated to public universities from State Fiscal Stabilization Fund revenue under ARRA be used to mitigate tuition/fee increases or modernize/renovate/repair facilities, consistent with ARRA provisions. (Sec. 436) <u>Table 9</u> compares the FY 2008-09 and FY 2009-10 resident undergraduate tuition and required fee rates for each of the 15 public universities.
- 8. **Per-Student Funding Floor.** Intent language is retained to pay for a funding floor of \$3,775 per fiscal-year-equated student from year-end General Fund/General Purpose unreserved balances. (Sec. 450)
- Indian Tuition Waivers. Intent language is retained to pay for unfunded Indian Tuition Waiver costs from year-end General Fund/General Purpose unreserved balances. Allocation of \$100,000 from Lake Superior State's appropriation for waiver costs at Bay Mills Tribal College is retained; a similar allocation of \$29,700 from Central Michigan's appropriation for Saginaw Chippewa Tribal College is added. (Secs. 451, 460, 461)

P. CAPITAL OUTLAY

For informational purposes, <u>Table 10</u> lists the Capital Outlay projects for Michigan's public universities that have been authorized since 1992.

Q. BOILERPLATE REPORTS

The table in the final section of this report provides a detailed list of reports required from public universities and other entities under the FY 2009-10 Higher Education budget act.
