## LARA FEE SUNSETS 2023

### **FAST FACTS**

- Half of LARA's annual budget is funded by restricted revenue.
- Many of LARA's restricted funds are supported by fee revenues.
- 16 separate MCL sections contain LARA fees that are scheduled to sunset in 2023.
- If the fees sunset, a revenue reduction of \$18.9 million would occur.

#### **INTRODUCTION**

State restricted funding supports approximately half of the appropriations included in the Department of Licensing and Regulatory Affairs (LARA) budget. In FY 2021-22, LARA's gross appropriation totaled \$517.2 million, with \$258.9 million (50%) funded by revenue from 45 restricted funds. These funds largely receive revenue collected from fees assessed under the various statutes and programs that LARA administers.

#### **OVERVIEW OF FEES SCHEDULED TO SUNSET**

Sixteen separate statutory sections have specified sunsets that either set the end date for a fee collection or reduce the fee amount to be collected. All of the applicable sections have fees that will sunset in calendar year 2023, with one section sunsetting in March and the remainder sunsetting in September. <u>Table 1</u> below provides an overview of these fees, with additional detail on each MCL section following.

The legislature may eliminate a sunset or extend it to a future date; all of the included sunsets were extended most recently by four years from 2019 to 2023. No action is required if the legislature wishes for a fee to sunset as scheduled.
