

# **2021 ACCOMPLISHMENTS**

- LARA achieved Gold Veteran-Friendly Employer status
- In accordance with ED 2020-7, LARA developed and enacted administrative rules that require health professionals to take implicit bias training as a condition of licensure or registration
- LARA worked with the Governor's office, legislative partners, DMVA, and other stakeholders to enact legislation that provides license reciprocity and fee waivers for veterans and their families



# **2021 ACCOMPLISHMENTS**



#### Bureau of Community and Health Systems (BCHS)

 Convened a Long-Term Care Workgroup with stakeholders that created recommendations about citation patterns, facility reported incidents, quality improvement/assurance, and enforcement



## **Bureau of Professional Licensing (BPL)**

Completed the fourth and final phase to transition all licensed professions to the MiPLUS platform



## Child Care Licensing Bureau (CCLB)

- Hosted access fairs in Detroit, Grand Rapids, and Traverse City
- Providing reimbursement to providers related to licensing costs

### Michigan Liquor Control Commission (MLCC)

Launched the Michigan Online Ordering system that modernizes how the commission does business



## Michigan Public Service Commission (MPSC)

• Launched Energy Affordability and Assistance Collaborative as part of the MI Power Grid Initiative.



## Michigan Indigent Defense Commission (MIDC)

• Approved new eligibility screening standard that ensures fairness in the criminal justice system




## LARA FY 2023 BUDGET

The LARA budget represents less than 2% of the statewide general fund budget





## **KEY GOALS**



- Provide broad, consultative support to skilled nursing facilities
- Invest in clean energy improvements for businesses and residents
- Streamline licensing and regulatory processes by continuing to modernize IT systems for critical programs
- Establish the Task Force on Foreign-Trained Medical Professional Licensing
- Improve services to licensees and applicants within Michigan's growing marijuana and liquor industries
- Expand outreach and education activities for the Public Service Commission

### I. Support additional consultation through state surveyors in skilled nursing facilities

\$1.6 million GF/GP funding and 10.0 FTEs to build upon infection control consultation efforts that began during the COVID-19 pandemic.

#### Expanded consultation means we focus on:

- Infection Control and Prevention
- Labeling/Storage of Drugs and Biologics
- Food Procurement, Storage, Preparation and Sanitary Service
- Free of Accidents and Hazards
- Quality of Care
- Development and Implementation of Comprehensive Care Plans
- Resident Rights

This ongoing investment will allow state surveyors to provide broader support to nursing facilities, including education and consultation services, improving the overall quality of care for residents

2. Investing in clean energy improvements for businesses and residents

\$5.0 million GF/GP one-time funding for the Michigan Saves Green Bank to leverage private investment in clean energy improvements for Michigan's residents and businesses

- Provides a credit enhancement to lenders
- Incentivizes lenders to provide more favorable rates and terms for renewable energy improvements

This investment will benefit property owners and the environment while supporting Michigan's clean energy economy

- Increased safety and health protections
- A cleaner environment
- More resilient energy generation

## 3. Modernizing IT systems for critical licensing programs

Information Technology Investment Fund (ITIF): \$6.5 million ITIF funding requests (DTMB budget) to update critical systems:

- BCC Licensing, Inspections, and Public Portal (\$3 million)
- BFS Storage Tanks Registration and Regulation (\$1.1 million)
- Central Cashiering System (C3) Modernization (\$2.4 million)

State Restricted Funding: \$2.3 million investment to replace the Corporations Online Filing System within the Corporations, Securities, and Commercial Licensing Bureau (CSCL)

- 4. Establish and Support the Task Force on Foreign-Trained Medical Professional Licensing
- \$1.1 million (state restricted) funding for the establishment and support of the Michigan Task Force on Foreign-Trained Medical Professional Licensing



5. Marijuana Regulatory Agency

- \$813,700 and 5.0 FTEs to adequately fulfill licensing and regulatory functions
- Supports increased costs for regulation and licensing in the adult-use market
- Shifts \$5.3 million and 49.0 FTEs to the Recreational Marijuana Regulation program from the Medical Marijuana Facilities Licensing and Tracking program
- Recognizes the shifting demand from the medical marijuana program to the adult-use market while continuing to ensure industry compliance with consumer health, safety and welfare regulations of both programs

## 5. Marijuana Regulatory Agency - Continued

- Medical Marijuana Operation and Oversight Grants
- Shifts \$3 million from the Marijuana Registry Fund to the Marijuana Regulation Fund to allow for a more sustainable funding source
- Grants have historically been provided to counties for education and outreach
- Funding from the Marijuana Registry fund revenue is no longer sufficient to support the continuation of these grants



6. Support Liquor Control Commission staffing to improve services to Licensees and Applicants

- \$600,000 to bolster staffing that will improve services to licensees and applicants
- Funding and FTEs would allow MLCC to continue all operations as directed under statutory and rule requirements
- Reduce wait times, improve response times, and provide improved customer services
- MLCC provides annual renewal services to approximately 102,800 licenses and permits with all requests beginning with the Licensing Division
  - Licenses and permits issued have increased by approximately 14% since 2018

7. Expand Public Service Commission Outreach and Education Activities

This funding is consistent with the MPSC's updated strategic plan, and in anticipation of recommendations coming out of two ongoing workgroups - the Customer Education and Participation MI Power Grid, and the Energy Affordability and Accessibility Collaborative

\$282,600 (state restricted) and 2.0 FTEs to expand outreach and education activities for the Michigan Public Service Commission (MPSC)

## Impact of Legislative Sunset Provisions

- LARA faces the sunset of 38 different fees in 8 separate public acts, which are all set to expire by September 30, 2023
- The removal of the sunsets would allow for existing fees to continue, beginning in FY 2024
- The first sunset would occur with Transportation Network Companies fees, which are set to expire on March 21, 2023
- LARA projects an \$18.9 million loss in revenue should the sunsets go into effect without legislative action to eliminate or extend the dates

- This budget makes strategic and fiscally responsible investments in Michigan's future by:
  - Improving Licensing Inspection Efficiency
  - Addressing Public Health Needs
  - Streamlining Modernization through Information Technology
  - Lowering Costs for Families
  - Improving Services to Licensees and Applicants

We look forward to partnering with you to enact our department budget for FY 2023. Our team is ready and willing to support the important work of our appropriations subcommittee.
