RE: May 2020 Consensus Revenue Estimating Conference

A Consensus Revenue Estimating Conference has been announced for Friday, May 15, 2020, convening at 9:00 AM. This Conference is held pursuant to Public Act 72 of 1991, which requires the Director of the Senate Fiscal Agency, Director of the House Fiscal Agency, and either the State Budget Director or the State Treasurer to hold at least two revenue estimating conferences each year, in January and May.

Executive Order 2020-77, Section 6, suspends all in-person government activities through May 28, and the principals of the Consensus Revenue Estimating Conference have determined that, for the first time, the Conference will be held remotely and broadcast live via the internet for the public to observe in accordance with governing statute. All sessions of the conference will be accessible to the public. The meeting proceedings will be broadcast by both the Michigan Senate and House TV internet feeds at the following sites:
