This conference is held pursuant to Public Act 72 of 1991, which requires the Director of the House Fiscal Agency, Director of the Senate Fiscal Agency, and either the State Budget Director or the State Treasurer to hold at least two revenue estimating conferences each year, in January and May.

The principals of the Consensus Revenue Estimating Conference have determined that the Conference will be held remotely and broadcast live via the internet for the public to observe in accordance with governing statute.
