This work project would allow the carryforward of \$5.0 million (STF) to allow for reimbursement of maintenance project work completed after September 30, 2019. Projects are to be completed by the end of the calendar year, with contract agencies submitting final costs for reimbursement within one month of completion of authorized work. Given the reoccurring nature of this activity, similar work project designations may be requested in the future.
